**DECLARATION OF CONFORMITY**  
**for plastic material used in contact with foodstuffs**

We declare herewith that the following product manufactured by us:

MATERIAL: Chrome nickel steel 316L and woven polyamide webbing band (Standard) or molded TPV-  
band (Protec) or Chrome nickel steel band (Protec-S, Raptor)  
Chrome nickel steel hook (Falcon), buckles (stainless steel)

conform to the requirements of the German law concerning articles of everyday use and/or the corresponding European regulations concerning plastics and the regulations (EU) 10/2011, 2023/2006 (GMP) and (EU) 1935/2004 in their current versions and are manufactured in accordance with the European Community regulations for Norm CE-EN 1082 and 13998:2003 and correspond to the requirements of the Law governing Foodstuffs and Utility Items.

Under the conditions of use as defined in the specifications, the total migration as well as the specific migration are below the legal limit. The test was performed in accordance with the Guidelines 82/711/EWG and 85/572/WG.

The materials and raw products used in manufacture correspond to the German law concerning articles of everyday use and/or the corresponding European Guidelines for plastics 10/2011 ff..

Specifications concerning intended usage or restrictions:

- Type(s) of foodstuffs with which the material MAY come into contact: meat, milk products, fish, general foodstuffs
- Type(s) of foodstuffs with which the material should NOT come into contact: corrosive substances may affect the performance, please see handling instructions for care and cleaning
- Length of time and temperature for treatment and storage conditions in the case of contact with the foodstuff: no restrictions known
- This Chain Mail Safety Glove is to be worn when working with hand knives or other cutting implements, particularly by butchers during cutting and boning work in the meat and food industry.

The production chain overview required under regulation (EG) Nr. 1935/2004 is guaranteed by the metal production code + date tag.

We further confirm that these products were not manufactured under exploitative working conditions as defined by the ILO Convention 182.
